The information and the rules given herein are applicable for admissions to the first year of two years full time Master of Computer Applications (MCA) post graduate degree programme of Bharati Vidyapeeth (Deemed to be University), Pune conducted at its following constituent units.

#### INTAKE FOR MCA PROGRAMME

- 1. Institute of Management and Entrepreneurship Development, Pune (Intake: MCA-60)
- 2. Institute of Management, Kolhapur. (Intake: MCA-60)
- 3. Institute of Management and Rural Development, Administration, Sangli. (Intake : MCA-30)
- 4. Yashwantrao Mohite Institute of Management, Karad. (Intake : MCA-60)
- 5. Abhijit Kadam Institute of Management and Social Sciences, Solapur. (Intake : MCA-30)
- The seats will be filled on merit, based on their performance in "**B-MAT-2023** Test", conducted by Bharati Vidyapeeth (Deemed to be University) at the designated centers.
- One seat over and above the sanctioned intake of the programme at each center is reserved for wards of migrants from J & K valley, Defence and Civil Service personnel engaged in fighting against terrorist activities in J & K valley (D.O. No. F10-1/2003-Desk (U) dated 5-12-2003). The candidates to be admitted against these seats must have appeared at the B-MAT-2023 conducted by Bharati Vidyapeeth (Deemed to be University) Pune. The seat will be allotted to the candidate who has secured highest marks in the entrance test among J & K candidates.

#### Note :

 Out of the sanctioned intake, 15% seats are reserved for Foreign / N.R.I. / PI.O. /OCI/ Institutional Quota Merit Category. Candidates desirious of getting admission under the Foreign / N.R.I. / PI.O. /OCI/ Institutional Quota Merit category will have to apply separately on a prescribed application form and submit the same to the Registrar, Bharati Vidyapeeth (Deemed to be University) Pune. The form fee for this category is **Rs. 1000/-** (non refundable). Seats remaining vacant after allotment to Foreign/NRI/PIO/OCI students (based on merit), will be allotted to Indian students under Institutional Quota on the basis of merit based on the marks obtained by them in **B-MAT-2023** Computer centre based entrance test. The last date for submission of form to this category at the above mentioned address is **30th March 2023 before 5.00 p.m.**

All the candidates seeking admissions will have to appear for computer center based Entrance Test **B-MAT-2023** conducted by Bharati Vidyapeeth (Deemed to be University), Pune. All candidates will have to apply online & fill the prescribed application form at the website : **www.bvuniversity.edu.in** 

#### 2 ELIGIBILITY

#### 2.1 MCA (Two Years Full Time)

Passed B.C.A/B.Sc. (Computer Science)/B.Sc. (IT)/B.E. (CSE)/B.Tech.(CSE)/B.E. (IT)/B.Tech. (IT) or equivalent Degree.

OR

Passed any graduation degree (e.g.: B.E. / B.Tech. / B.Sc / B.Com. /B.A./ B. Voc./ etc.,) preferably with Mathematics at 10+2 level or at Graduation level

Obtained at least 50% marks for open category (45% marks in case of candidates belonging to SC/ST category) in the qualifying examination. (for students having no Mathematics background compulsory bridge course will be framed by the respective University/ Institution and additional bridge courses related to computer subjects as per the norms of the concerned University).

**Note:** Candidates who are presently studying in the final year of Bachelor's degree course can also appear for the entrance test and seek admission for MCA programe in the year **2023-24**. However, They are eligible for admission only if

- (a) the basic qualification mentioned in 2(I) above are full filled.
- (b) The last date to submit all the certificates in original shall be **30th September 2023**. If the certificates are not submitted by the said date, the eligibility will not be granted and the admission would automatically stand cancelled. The candidate should be an Indian national.

#### 3. BASIS OF SELECTION FOR ADMISSION

- 3.1 A Candidate desirous of seeking admission to MCA Programme (MCA s Years) should fulfill the minimum eligibility condition as stated in point no. 2 above. The final admission will be offered based solely on the merit obtained at the all India B-MAT-2023 Computer centre based entrance test conducted by Bharati Vidyapeeth (Deemed to be University), Pune.
- 3.2 He/She must have appeared for the **B-MAT-2023** Computer centre based entrance test, conducted by Bharati Vidyapeeth (Deemed to be University), Pune at designated centres.
- 3.3 The Candidate shall be offered admission on the basis of his/her rank in the final merit list and availability of the seats for a particular programme at a particular Institute of the candidate's choice at the time of counseling and admission in the concerned Institute. Mere appearance in the Computer centre based entrance test and inclusion of name in the merit list does not confer any automatic rights to secure admission to the programme offered by the institute. The selection and admission to the programme is subject to fulfilling the eligibility criteria.

- 3.4 In the case of candidates securing equal aggregate marks their relative rank will be determined on the basis of following order of preference:
  - a) If equal, the candidates will be ranked according to their percentage of marks obtained at HSC or its equivalent examination.
  - b) If equal, the candidates will be ranked according to their percentage of marks scored at SSC or its equivalent examination.
  - c) When all the above scores are the same, the candidates will be ranked on the basis of computerized random numbering.

#### 4. NATURE OF COMPUTER CENTER BASED ENTRANCE TEST "B-MAT-2023"

All candidates desirous of taking admission for MCA Programme must appear for B-MAT-2023

- 4.1 The **B-MAT-2023** is a Computer center based entrance test for admission to MCA Programme will be of 200 marks and shall be of 180 minutes duration.
- 4.2 The entrance test **B-MAT-2023** for admission to MCA Programme will consist of in all 200 marks. It consists of 200 multiple choice questions one mark each with four alternatives, with only one correct or most appropriate answer. One Mark will be awarded for each correct answer. There is no negative marking. The break-up off marks will be as follows.

- 5.3 The entrance test fee, once paid, will not be refunded under any circumstances. Candidates who remain absent for the entrance test will forfeit their entrance test fee.

The merit list of **B-MAT-2023** entrance test will be displayed on its website **www.bvuniversity.edu.in** It is not possible to send individual invitation for counselling to the candidates. It shall be the responsibility of the individual candidate to see their own merit number and appear for the counselling at the centre of his/her choice as per schedule will be notified at the website.
