Sir,

I am pleased to inform you that, this university has taken all precautions to prevent ragging in this university. Some of the steps taken by the university are as follows:

- 1) At the time of admission all the students and parents are clearly informed of the ill effects of ragging and asked them not to involve in ragging.
- 2) The senior students are also informed of the punishments to be imposed on those students involved in any form of ragging viz., teasing, abuse, physical torture etc.
- 3) The students as well as the parents are executing an affidavit as prescribed in the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009.
- 4) Hoardings (Picturized) are displayed in the prominent places including the entrance of colleges, highlighting the points mentioned in the Curbing the Menace of Ragging in Higher Educational Institutions, 2009 regulations.
- 5) Posters (contents are - ragging in any form is strictly prohibited, type of punishment, fine and expulsion from the university etc) are printed and displayed in the notice boards as well as in the hostels, library, canteen etc.


- a) Anti Ragging Committee
