Tender Details

Bharati Vidyapeeth (Deemed to be University) is one of the leading Institutions of Higher Education in India. It is reaccredited with A+ grade (CGPA 3.53) during third cycle by NAAC, ranked 66th in NIRF 2018 and graded as Category-I University by the UGC under graded autonomy regulations.

Tenders are invited from the interested parties who fulfill the following criteria in sealed covers as technology providers for BBA, MBA, BA, B.Com, and M.Com programs of the University through fully online mode.

Qualifying criteria for the bidders:

The bidders should have

- i. Offices in major locations across the country with minimum 1000 square feet Space for each office and appropriate infrastructure facilities.
- ii. Minimum five years experience of working with the universities and or higher education institutions for similar work.
- iii. Assisted the universities or higher education institutions with minimum of 5000 enrolment in a year for last three consecutive years.
- iv. Average annual turnover of Rs.25 Crores for last three consecutive years.
- v. Appropriate latest ICT technology such as studio to device and virtual classroom.
- vi. Sufficient number of employees on the roll.
- vii. The bidders should be a direct company and shall not be a third party.
- viii. The bidder shall not submit more than one tender and under no circumstances the bidders or his partners should have any business relations with the other bidders.

Documents to be supplied by the bidder:

- i. Duly registered and authenticated copies of the registration of the company.
- ii. Testimonials from the clients such as universities or higher education institutions regarding the performance, enrolment and technology support.
- iii. Audited income-expenditure and balance sheet for last three years.
- iv. Details of the address of the head quarters and branch offices.
- v. Details of the technology, studio, technical man power, etc.
- vi. Brief profile of the company of the bidder.
- vii. List of the clients.

Procedure:

The university while processing the tenders will follow the following procedure:

1. The bidders shall submit their technical and financial bid in a separate sealed cover with the name of company.
2. The university shall invite all bidders for the presentation before the Expert Committee to present their profile, delivery, technology, etc.
3. The Expert Committee based on the presentations and technology shall short list the bidders.
4. The university shall then open the technical bids in presence of only those bidders who are shortlisted by the Expert Committee.
5. Thereafter, the university shall open the financial bid in presence of only those bidders who are qualified in technical bid.
6. The university reserves the right to reject any or all tenders without assigning any reason.
7. The university Expert Committee may visit the bidders head office and its branches to inspect the infrastructure and other facilities.
8. The final decision of awarding the tender will be taken by the university authorities.

The interested bidders/companies may submit their tenders in two separate sealed covers to the Registrar, Bharati Vidyapeeth Deemed University, Pune along with the tender processing fees of Rs.1,00,000/- (Rs. One Lakh) by Demand Draft in favor of “The Registrar, Bharati Vidyapeeth Deemed University, Pune”, payable at Pune. The processing fees shall be non refundable.

The bidders shall submit the tenders with all the documents to the Registrar on or before 7th Dec 2018 the late or incomplete tenders shall not be entertained.

The University shall not be responsible for delay/loss or non-receipt of requisite information/necessary documents sent or forwarded by the bidder/participant.
