Minutes of HOD meeting (16 October, 2024)

1. Decision Regarding Unit Tests for Branch Change Students:

The process of change of branch of students was completed on 14/10/2024. It is necessary to teach & cover the syllabus of the subjects included in the changed branch for all these students. A meeting of all heads of the departments to discuss this was conducted on 16/10/2024.

- a) Students from sem-I who have changed their branches are required to appear for the Unit Test II for common subjects only (Engineering Mathematics/Engineering Physics/ Engineering Chemistry, as applicable) scheduled on 17th October 24.
- b) Branch-Specific Subjects: Online, offline/ hybrid classes for branch-specific subjects will commence from 18/10/2024 for the students who have changed their branches. The time-table and mode of teaching will be displayed by the respective departments. The records of lectures conducted (offline/online) along with the attendance of the students need to be maintained metaculously by the respective subject teacher. Respective heads to observe the conduction of classes, coverage of syllabus & PBL of these students.
- c) Schedule of covering practical of skill development courses as applicable will be displayed by the respective department. These practical needs to be completed before the commencement of unit test.
- d) These students are expected to complete the term work and PBL of core subjects as guided by the respective subject teachers, before the commencement of unit test.
