The B.Pharm second year programme is conducted at the Bharati Vidyapeeth (Deemed to be University), Poona College of Pharmacy, Pune. You are required to be present for counseling and on the spot admission for B.Pharm second year programme as per following schedule:

The Fees shall be revised upwards @ 5% per annum. The Remaining Candidates will be called as per availability of seats in Direct Second Year B.Pharm.

It is compulsory for either you or your representative to attend the counseling in order to claim for admission, if you remain absent when your name is announced for counseling, you stand to lose the claim for admission. In this session of provisional admission, you will be called for counseling in accordance with the merit in the regular category merit list and will be offered admission to B.Pharm Second Year Programme as per the availability of the vacancy at that particular point of time in the counseling session.

#### Important suggestions

- 1 You are instructed to bring with you all relevant documents (original and two sets of attested copies of each).
- 2 The students who are given provisional admission will be required to pay tuition fee **Rs.1,50,000/-** (Regular Category) and additional **Rs.1,000/-** against 'Caution Deposit' at the time of admission.
- 3 You will be required to pay the entire amount of fees at the time of admission.

You will be required to pay the entire amount of fees at the time of admission through online mode at [www.bharatividyaapeethfees.com](http://www.bharatividyaapeethfees.com) or by Demand Draft (DD) drawn in Favour of "**Principal, Poona College of Pharmacy, Pune** Payable at **Pune**. As you are aware of the total intake of B.Pharm second year, it may happen in the cases of some candidates that admission to the programme would be over before their turn comes up. It will then not be possible to consider them for admission to the programme. In such situation we do not owe any responsibility. The commencement of academic session to the B.Pharm Second Year will be informed by the college. All students who will be given provisional admissions to the programme have to compulsorily attend from that day.
