The Fees shall be revised upwards @ 5% per annum.

You will be required to pay the entire amount of fees at the time of admission through online mode at www.bharativedyapeethfees.com or by Demand Draft (DD) drawn in Favour of "Principal, Poona College of Pharmacy, Pune Payable at Pune.
