Only those candidates present at 10.00 am will be considered for counselling and on-the-spot admission. No change of time and date is allowed.

The seats will be allotted in the order of merit as per intake capacity of the programme in Regular Category (Self-Financing Section). Call for counselling is not guarantee of seat, it is subject to intake capacity in Open Merit Category and availability of a seat at that point of time.

Kindly attend the counselling with all relevant documents in original and photocopy. You must submit all the original documents in the college at the time of counselling and on the spot admission. If you are given provisional admission then you will be required to pay the tuition fees on the day of counselling itself, failure to present in person and failure to remit the fee will result into loss of your claim for the seat. No further correspondence will be entertained.
