Several Theories & Models on Capital Structure Decisions developed & used in the past are based on attainment of a single objective of maximisations of profit or minimisation of risk leading to erroneous and irrational decisions in today's complex business environment. 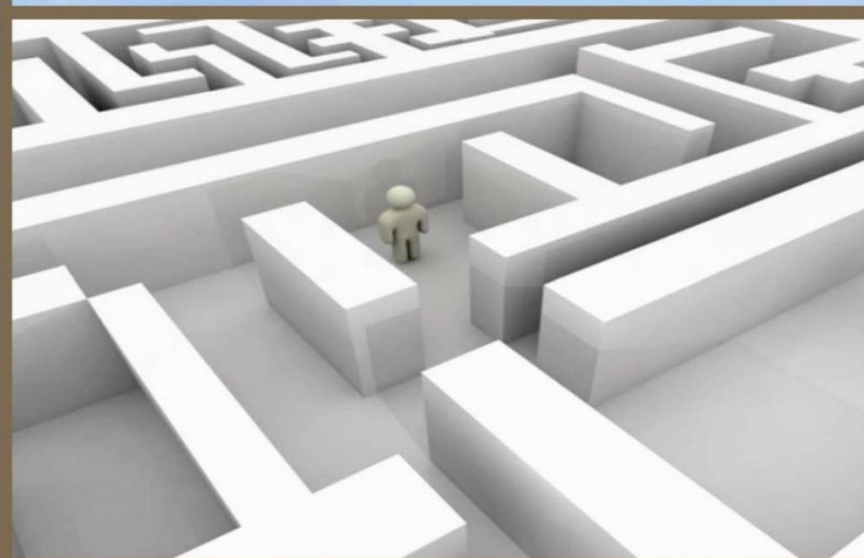
