3. **Institution's Innovation Council (IIC):** The IIC, which plays a vital role in fostering innovation and entrepreneurship among students and faculty, was another focal point of the visit. The team reviewed the council's activities, completed projects, ongoing projects, and its role in supporting innovative academic and industry-relevant projects.



4. **IQAC Room:** The **Internal Quality Assurance Cell (IQAC)**, pivotal in overseeing the institution's continuous improvement and quality enhancement initiatives, was thoroughly reviewed. The air-conditioned IQAC room, equipped with modern tools such as **two computers, two printers, and a smart board**, serves as a hub for NAAC-related activities. It was noted that all **NAAC coordinators** and a **designated clerk** work from this room, which is also used for managing digital systems, including the **CleverGround software** used for document management and report generation. This infrastructure and organization reflect the institution's commitment to maintaining the highest quality standards.

Interactions and Key Insights:

One of the most valuable aspects of the visit was the **interactive sessions** between the Vice Chancellor and the staff and students. The Vice Chancellor engaged with various stakeholders, including:
