6. Descriptive study of Jangamavisha, definition, classifications, sources, content of venom classical signs and symptoms and treatment of poisoning including
 haemotoxicmyotoxic and vascolotoxic snakes
 Vrischika (scorpion),
 Alarka (dogs)
7. Garavisha and Dushivisha, their varieties, signs, symptoms and management with contemporary relevance,
8. Detailed study of Madyavisha (Alcoholism) and substances acting on the nervous system; substance abuse.
9. Detailed study of the contemporary knowledge features and management about vishajanyajanpadodhvansaniyaroga (community health problems due to poisons - Environmental pollution, water pollution, soil pollution, air pollution)
10. Concept of Virudhaahara, Aaharavisha.(Food poisoning) and Satmyasatmyata in contemporary and Ayurvedic views
11. Diagnosis & management of drug induced toxicity,drug interactions and incompatibility
12. Death due to poisoning, Duty of physician in poisoning, in cases of suspected poisoning. Post mortemfindings in poisoning.
13. Extra -corporeal techniques (dialysis etc) for removal of poisons.

PART-B
