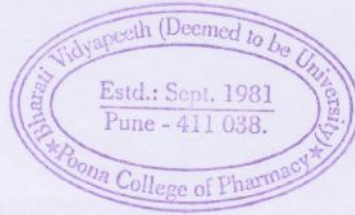

**Note:**

- **Candidate must be present in-person**
- The Candidate should bring **print out of self-verification done on the State CET Cell website** (Provisional allotment letter) with College admission receipt and Bonafide certificate, in case the candidate has already taken admission in other College.
- The candidate should bring all original documents for the admission process. If a candidate is unable to produce original certificates at the time of his/ her admission on account of admission already secured in other institute, he/she shall produce the Original Bonafide Certificate and Photo copies of all such documents attested by institute. Such candidates shall be required to pay the fees immediately at the time of admission and such candidate shall be permitted to submit the required original documents **on or before 15<sup>th</sup> September 2023 (4.00 pm)** otherwise his/ her admission will stand automatically cancelled and fees paid shall be forfeited as per CAP admission policy.

- The candidate has to pay prescribed fees of **Rs. 16,000/-** immediately at the time of admission.
- Candidate has to cancel his/her earlier admission at his/her own risk and cost. Candidate should cancel previous admission immediately to confirm the allotted admission in this institute.
