It is hereby notified for all the concern the following Rules for transfer or migration of student of Bachelor of Physiotherapy (B.P.Th.) Programme:

- A student studying in the Bharati Vidyapeeth (Deemed to be University) School of Physiotherapy may apply within fifteen days from the date of declaration of the result of the first professional examination of B.P.Th course.
- 2. Transfer or migration shall not be claimed as a matter of right by the student.
- 3. An applicant student shall obtain the No Objection Certificate from
 - the relieving institute
 - ii. the receiving institute and
 - iii. the Concerned Universities.
- The validity of this N.O.Cs. shall be for that batch only and up to 03 months from the date of its issuance.
- Transfer of the student will be subject to availability of the vacancy for the respective academic year maximum up to 10% intake capacity of institute.
- 6. Eligibility: Student should clear their first professional examination in first attempt.
- 7. Migration or transfer according to the following criteria, ,
 - a. Death of parent/s or guardian
 - b. Merit basis
 - c. Students who have applied on self-medical ground.
- The No Objection Certificate from the relieving OR the parent institution under the signature of its Dean or Director or Principal, as the case may be, shall indicate the following details;
 - a. The remark that no outstanding dues payable to the parent college;
 - b. the date of birth of the student as per the college or institution's record;

- 9. If there are more number of applicants seeking transfer to a particular college or the institution in comparison to the vacancies available, the following criteria shall be applied, namely:
 - i) The candidate with higher total number of marks obtained at the H.S.C. or equivalent examination shall be given preference.
 - ii) if the tie persists, the candidate with higher marks in anatomy shall be preferred.
- 10. The applications seeking transfer or migration, duly scrutinized and found valid by the Registrar, along with relevant documents shall be then placed before the Vice-Chancellor for approval.
